

- 1. Connect the receiver to your flight controller as shown in the diagram below. 2. Install the active portion of the antennas (the exposed section at the end of
 - the antenna wire) as far as possible from metal, carbon fiber, and wiring. WARNING: Do not kink, cut or damage the antenna wire. The

The SPM4650C requires a 3.3V – 8.4V volt power supply from the flight controller.

- 1. Press and hold the bind button on the receiver.
- 2. Power on the Aircraft. The orange LED will begin flashing.
- 3. Put the transmitter into bind mode. The LED on the receiver will light solid when the transmitter and receiver are bound.

Alternatively the SPM4650C receiver may be put into bind mode through the flight controller interface.
