## **Waterproof Component**

Your new Horizon Hobby® Spektrum™ ESC has been designed and built to allow you to operate the product in many "wet conditions," including puddles, creeks, wet grass, snow and even rain.

While waterproof, this component has not been designed to be immersed in water for long periods of time and should NOT be treated like a submarine. In addition, most metal parts, including any screws and nuts, as well as the contacts in the electrical cables, will be susceptible to corrosion if additional maintenance is not performed after running in wet conditions.

To maximize the long-term performance of your ESC and to keep the warranty intact, it should only be used as described in the "Usage Conditions" section of this manual. Additionally, the procedures described in the "Wet Conditions Maintenance" section must be performed regularly if you choose to run in wet conditions. If you are not willing to perform the additional care and maintenance required, then you should not operate your vehicle in those conditions.

**CAUTION:** Failure to exercise caution while using this product and comply with the following precautions could result in product malfunction and/or void the warranty.

#### **General Precautions**

- Read through the wet conditions maintenance procedures and make sure that you have all the tools you will need to properly maintain your ESC.
- Do not operate your ESC where it could come in contact with salt water (ocean water or water on salt-covered roads), contaminated or polluted water.

Salt water is very conductive and highly corrosive, so use caution.

#### **Usage Conditions**

Your ESC will operate successfully in any of the following, individual-usage scenarios:

- 2 hours continuous operation in damp grass or vegetation.
- 2 hours continuous operation in heavy fog (95% humidity, saturated air, condensing water).
- 1 hour continuous operation in light rain (<0.10 in/2.5mm per hour).</li>
- 15 minutes continuous operation in heavy rain (>0.30 in/7.6mm per hour).
- 1 hour continuous operation in light sleet (<0.10 in/2.5mm per hour).</li>
- 1 hour continuous operation in light snow (<0.25 in/6.35mm per hour).</li>
- 45 minutes continuous operation in standing or running fresh water (the water level should always remain below the vehicle frame), or constant splashing water, without any immersion of waterproof component(s).
- 5 minutes continuous operation in standing or running fresh water (the water level should never rise higher than 0.5 in (about 10mm) above the vehicle frame), constant splashing water, or frequent, intermittent immersion of waterproof component(s).
- 1 hour continuous operation in damp sand, dirt, mud or snow (the material level should always be below the vehicle frame), constant splatter without any immersion or coverage of waterproof component(s).

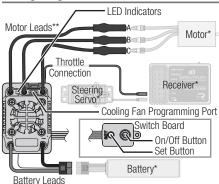
Furthermore, when appropriate maintenance procedures (as described below) are performed promptly following exposure, the ESC will remain best protected from corrosion or other long-term, water-related damage.

#### Wet Conditions Maintenance

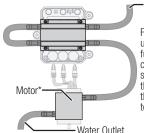
- Gently rinse the mud and dirt off the ESC with a garden hose
- Remove the battery pack(s) and dry the contacts.
- If you have an air compressor or a can of compressed air available, blow off the ESC to help remove any water that may have gotten into small crevices or corners. Dry any water that may be inside a recessed connector housing.
- Let the ESC air dry before you store it. Water may continue to seep or evaporate out of tight areas for a few hours

**NOTICE:** Never use a pressure washer to clean your vehicle.

For Marine ESCs use large silicone fuel tubing for water cooling. Water should flow through the ESC first, then the motor, and finally to the water outlet.

## **Throttle Signal**

#### **Smart Throttle**

The Spektrum Firma™ ESC is compatible with Smart Throttle. Smart Throttle combines throttle signals with telemetry data from the ESC on one normal, three-wire servo connector. Smart Throttle compatible receivers will detect a Smart Throttle ESC and automatically begin to send telemetry information to your transmitter.

Using the Smart Throttle connection this ESC can send voltage, current, and other telemetry data. It can also pass along battery data from compatible Spektrum Smart batteries. A Spektrum Smart battery with IC3™ or IC5™ connector is required for battery data. EC3™ connectors are compatible for basic operation, but will not provide Smart battery data.

Only certain Spektrum telemetry receivers include Smart Throttle, check your receiver manual for more information. If the ESC is not connected to a Smart Throttle compatible receiver no telemetry data from the ESC will be available, but the ESC will operate normally with a common servo signal (PWM).

#### **Normal Servo Signal (PWM)**

The Firma ESCs are fully compatible with common RC receivers and will use a conventional PWM signal for basic operation.

## **Installation and Wiring**

- Mount the ESC and power button with the included mounting tabs, double sided tape or hook and loop material. Select a location to mount the ESC with good ventilation for cooling. The ESC mounting tabs can also be used to secure the ESC to the vehicle's chassis.
- Connect the three motor wires from the ESC to the motor wires. Connect A on the ESC to A on the motor (B to B and C to C). In the event the motor spins the wrong direction, reverse any two wires.
- Connect the throttle servo lead to the throttle port on your receiver.
- Secure all wiring so it is protected from damage or being caught by moving parts.

**NOTICE:** Do not connect a dedicated receiver battery to the receiver along with the ESC. When the ESC is turned On it will provide the receiver with 6V regulated power from the main battery through the throttle connection. The ESC may be damaged if the receiver is also connected to a dedicated receiver battery.

#### **ESC and Transmitter Calibration**

Start with the bound transmitter and receiver.

- Set the transmitter throttle channel to 100% travel and trim to neutral.
- Power ON the transmitter, and connect a fully-charged battery to the ESC.
- While pressing and holding the set button, power ON the ESC.
- When the red LED begins to flash, release the set button.
  - The ESC enters programming mode if the button is pressed for more than three seconds.

**TIP:** The red LED flashes when the ESC enters calibration mode. If the green LED is flashing the ESC is in programming mode.

- With the throttle trigger in neutral, press and release the set button.
  - The red LED stops flashing. The green LED flashes once and the motor buzzes to indicate the neutral position is set.
- Holding the throttle trigger at full throttle, press and release the set button.
  - The green LED flashes twice and the motor buzzes twice to indicate the full throttle position is set.
- Holding the throttle trigger at full brake, press and release the set button.
  - The green LED flashes three times and the motor buzzes three times to indicate the full brake position is set.

The motor operates normally after calibration is complete.

## **Button Programming**

Power on the transmitter.

Connect battery to the ESC and power on the ESC.

Hold set key for 1 second.

Green LED flashes.

Release the set button to enter programming.

Press and release the set button.

The number of green LED flashes = programming number.

Reset all programming items. Pres and hold the set button for 5 seconds.

Hold the set button for 3 seconds to select the programming item.

The number of red LED flashes = the option number within the programming number.

Press and hold the set button for 3 seconds to save the selected option.

Power off the ESC to quit programming mode or to enter another programming item.

## Programming with the SPMXCA200 Smart Programmer Box

- 1. Connect the programming lead from the programmer box to the programming port on the ESC.
- 2. Connect a battery to the ESC.
- Power on the ESC and select the parameter with the SELECT button.
- Change the values of the selected parameter with the EDIT button
- Press the SAVE button to save the changes. The ESC requires a power cycle to implement the saved changes.

## Firma Programming

Advanced features for the ESC may be accessed directly through your Spektrum compatible transmitter (DX5C, DX5 Rugged, DX5R, DX5 Pro AND DX6R) when using a compatible Spektrum™ Firma™ Smart speed control with a Smart compatible telemetry receiver.

#### **More Programming Options**

- 1. Power ON the transmitter.
- 2. Power ON the Smart equipped vehicle.
- When the Smart logo is visible on the Main Screen of your transmitter, scroll to the Firma Programming page.
- Follow the on-screen prompts as directed. (Turn wheel all the way to the Right and hold for 5 seconds, then all the way to the Left and hold for 5 seconds.)
- The menu will change to ESC programing options, at which time throttle is disabled. The vehicle will not respond to throttle commands while in the ESC programming menu. Normal throttle control will resume

when you select one of Exit options on the Smart ESC page.

The functions listed in the transmitter menu are same as the Spektrum ESC program box.

- Use the throttle trigger to move the menu. Pull
  the trigger (forward throttle) to move the menu
  down. Push the trigger (reverse throttle) to move
  the menu up.
- Cursors next to the line show which function is available to select.
- Turning the wheel to the left or right will let you access the parameters within each function.
   An asterisk (\*) next to the parameter shows the ESC's default setting.
- Select the Exit option you want by moving the cursor to the chosen position. Then turn the wheel to the Left or Right to exit the Menu.

Save w/Exit: Saves any parameter settings changed.

**Default w/Exit:** Returns all parameters to ESC default settings.

**Exit:** Leaves the Smart ESC menu, and does not save any changes.

Once you choose an exit option you will hear the normal startup tones as the ESC reconnects with the 5Pro. Normal throttle control will only be restored after selecting one of the Exit options.

**IMPORTANT:** You can access other transmitter menu functions away from the Firma Programming screen, but you cannot drive your until you Exit the Firma Programming screen. While the Firma Programming screen is active, the throttle is disabled on the vehicle. Steering control remains active during ESC programming.

## **Operation**

- 1. Connect a battery to the ESC.
- Leave the transmitter throttle at neutral and press the On/Off button on the ESC to turn it on. The ESC will cause the motor to make several tones.
   The number of tones indicates (1) the ESC is in operation (2) the LiPo cell count detected and (3) the ESC is in a ready-to-use state.
- Press the On/Off button or unplug the battery to turn off the ESC.

**NOTICE:** Do not leave a battery connected with the ESC turned off for extended periods of time. Always unplug the battery for storage or the battery may be damaged.
